### LAKE DREDGE UPDATE

**S**uperior Seawalls provided the winning dredge bid and is currently working with our team to develop a contract that includes the details necessary to complete the dredge.

Once the contract is complete, the work can begin. We remain optimistic that the dredge will be completed yet this year.

Homeowners along the shoreline will have the opportunity to have their shoreline area dredged as well, at the homeowners expense. This will provide an opportunity for shoreline dredging at a discounted rate, since the Contractor will already be working in our lake. A notice will be issued once the details are available.

### ELECTROFISHING SURVEY

JadEco will be performing an electrofishing survey to determine the quantity and health of the fish in our lake. The results of this survey provide needed data to make informed decisions regarding fish stocking and creel limits. A notice will be issued once a date for the electrofishing survey is determined.

#### WINTER BOAT STORAGE

#### **NEW at the Campround!**

A winter storage rental program is now available for landowners within the RCD district, and while all landowners qualify, there will be a limited number of spaces (14) available.

**A** renter will be able to store a registered boat with trailer at the campsite from September 1 to April 30 with the following restrictions:

• Only boats with trailers 24' and under in length will be allowed to be stored at the campsite.

• Renter must provide 2x12s to rest tires and tongue on, to protect the property from damage.

• Window to place boat with trailer for the season will be from September 1-30.

• Window to remove boat with trailer from storage will be from April 1-30.

**R**enter's boat/trailer still in storage after May 15 will be towed away at

The RCD may terminate a rental agreement for non-compliance with no refund issued to the renter.
