# 2023-2024 Lost Lake RCD DEER BOW HUNTING Regulations & Liability Waiver

Archery Deer Hunting is allowed in the area north & west of the campground (on the other side of the creek).

### October 1, 2023 through January 14, 2024

EXCEPTION: Archery Deer Hunting is CLOSED during Firearm Seasons Nov.17-19 and Nov.30-Dec.3, 2023.

### Permission to hunt is allowed by permit only. Rules are as listed below:

- 1. All hunters must register by September 1<sup>st</sup> with a non-refundable fee of \$50 (check made out to RCD) and have their tree stands in place by September 15<sup>th</sup>. A signed liability waiver will be kept on file with the RCD office. Hunter must also provide a copy of their hunting license & deer tags.
- All bow hunting rules and regulations as posted on the Illinois DNR website must be adhered to. A copy of your hunting license and bow hunting permit shall remain on file with the RCD office
- 3. Up to nine bow hunting permits will be made available by a random weekly drawing. The only areas available to hunt is the RCD property north of the campground creek.
- 4. If more than nine hunters sign up, necessitating a lottery, the hunting coordinator will notify hunters of their designated weeks. Weeks run Friday through the following Thursday with hunters being notified the Thursday before. Names will be re-submitted automatically unless you opt-out for that week.
- 5. To be eligible to receive a permit, you must be a taxpayer in the RCD district and be within good standing with the RCD. ONLY the person listed on the permit is allowed to hunt RCD property with the exception of one minor, under 18, who may hunt with the permittee, as long as IDNR Youth License requirements have been met.
- 6. An RCD permit will be issued and shall be posted in the vehicle (if parked) or on your person while hunting the campground property.
- 7. Areas to hunt are marked on the attached RCD property map (available in the RCD office)
- 8. No screw-in type tree stands or steps are allowed on RCD property. No tree stand shall be placed or hunting performed within 100 yards of a home. You must label your stand with your contact information and remove the deer stand by April 1<sup>st</sup>.
- 9. If you harvest a deer, you must notify the RCD. If a deer you are tracking crosses adjacent private property, you must notify the RCD immediately so that we can get permission from the property owner for you to enter their property to track the deer.
- 10. The RCD reserves the right to cancel the program or revoke a permit at any time.

## 2023-2024 Lost Lake RCD TURKEY BOW HUNTING Regulations & Liability Waiver

2024 Turkey Seasons: 1st: April 15-19 2nd: April 20-25 3rd: April 26-May 1

4<sup>th</sup>: May 2-8 5<sup>th</sup>: May 9-16

### Permission to hunt is allowed by permit only. Rules are as listed below:

- 1. All bow hunting rules and regulations as posted on the Illinois DNR website must be adhered to.
- 2. A signed liability waiver will be kept on file with the RCD office. A copy of your turkey tags and hunting license shall remain on file with the RCD office
- Up to nine bow hunting permits will be made available for the 2024 turkey season for each week. The
  only area available to hunt is the RCD property north of the campground creek and at the back of the
  campground.
- 4. If more than nine are signed up for a week, names will be drawn on the Wednesday prior and the selected people will be notified on Thursday.
- 5. To be eligible to receive a permit, you must be a tax payer in the RCD district and be within good standing with the RCD.
- 6. An RCD permit will be issued and shall be posted in the vehicle (if parked) or on your person while hunting the campground property. Hunters are asked to park at the turnaround past the dam or down in front of the campground entrance and to sign in at the kiosk.
- 7. To be eligible to receive a permit, you must be a tax payer in the RCD district and be within good standing with the RCD. ONLY the person listed on the permit is allowed to hunt the RCD property with the exception of one minor, under 18, who may hunt with the permittee, as long as IDNR Youth License requirements have been met.
- 8. Areas to hunt are marked on the attached RCD property map (available in the RCD office)
- 9. No screw-in type tree stands or steps are allowed on RCD property. No tree stand shall be placed or hunting performed within 100 yards of a home.
- 10. If you harvest a turkey, you must notify the RCD.
- 11. The RCD reserves the right to cancel the program or revoke a permit at any time.
