3. The renter is responsible for closing and locking all doors and windows before leaving the property.
4. Alcoholic beverages are prohibited on RCD property, unless the renter submits a Certificate of Insurance naming Lost Lake RCD as an additional insured during the event, and by submitting a signed, notarized Liability Insurance Agreement.
5. No smoking or vaping is permitted in the building.
6. Music and noise must be held to a reasonable level with regard to surrounding residents. We reserve the right to terminate any event where people become disruptive, destructive, or disrespectful.
7. Do Not Throw Rocks into the Lake.
8. The event must end by 10:00 p.m. Cleanup must be completed and the building vacated by 11:00 p.m.
9. A Security Deposit is required. The deposit will be refunded once the keys are returned and the premises are checked by RCD staff. All facilities must be left in the same condition as prior to rental.
